CLAUSE 1

CO-OPERATION

CLAUSE 2

SCOPE OF THE MoU

VALIDITY


3.1 This Agreement will be valid for **Three years** until it is expressly terminated by either Party on mutually agreed terms, during which period, the Second Part.



